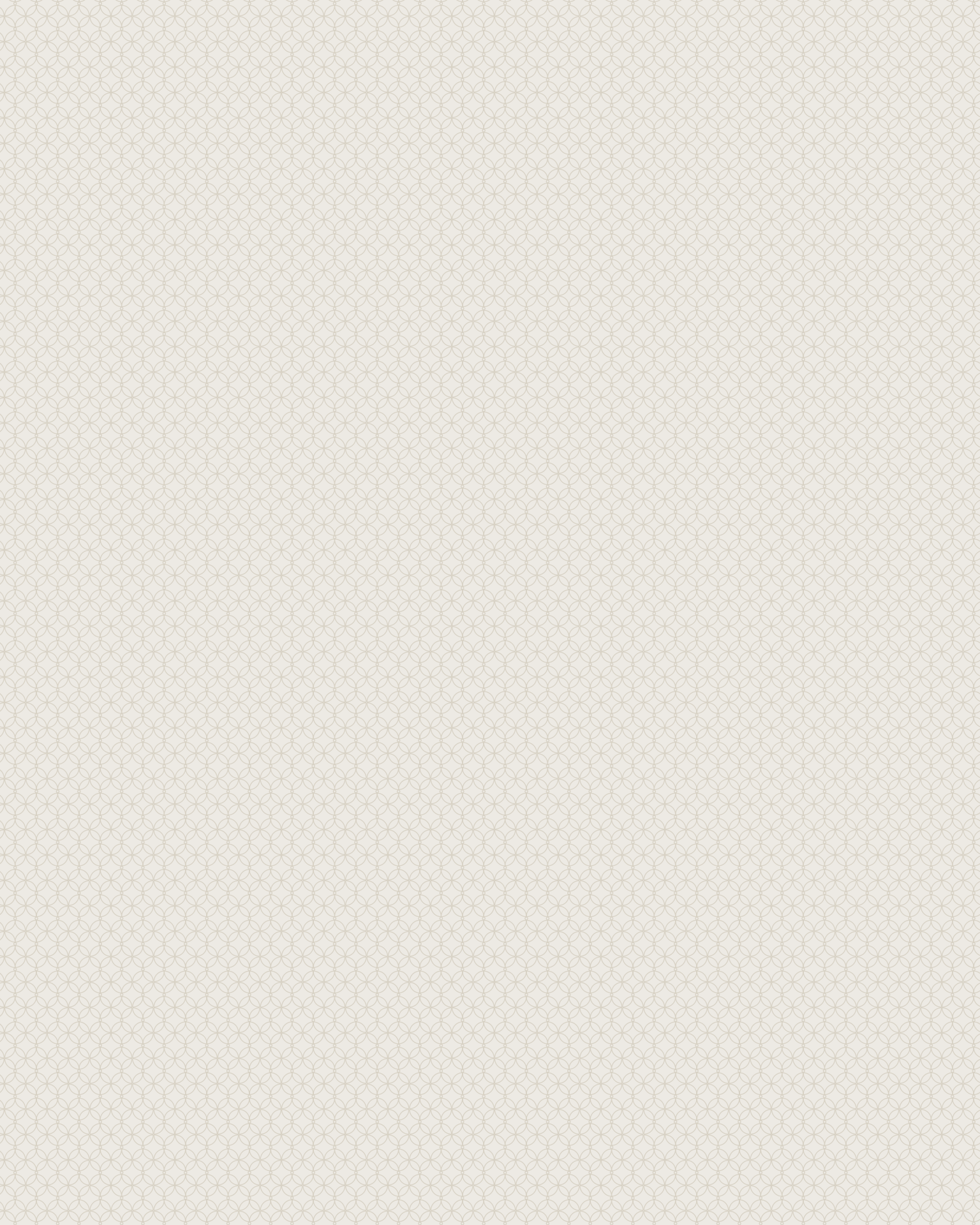

A Legendary Heritage

WHEN RIVIERA GLAMOUR ARRIVED IN THE BAHAMAS

It started in 1959 with a handshake between two of the world's richest men. Huntington Hartford II, dubbed "The most fantastic man in the world" by Andy Warhol, purchased the island estate of industrialist Axel Wenner-Gren, just across the waterway from Nassau. Renaming it Paradise Island, he envisioned a resort more beautiful—and much closer—than the French Riviera.

To fully realize his vision, Hartford spared no expense. He imported the staff from the world's most glamorous hotel, the Hotel du Cap. He hired world #1 golfer Gary Player as the head golf pro, and world #1 tennis player Pancho Gonzales as the head tennis pro. And he graced the property with terraced gardens, fountains, and statuary from Europe, along with

magnificent 12th-century Augustinian cloisters shipped piece-by-piece from the Pyrenees.

In 1962 Hartford welcomed over 1,000 of his friends—including Sinatra, Elvis, Gabor, Hearst and a host of dukes, earls, and ambassadors—to the "Bal du Paradis," his debut party for Paradise Island and his new resort, The Ocean Club. Benny Goodman led his orchestra as fireworks from Monaco lit the sky. The party lasted for days. Everyone was inspired, pampered, and instantly smitten. More than anything, they fell in love with The Ocean Club's sugary sand beaches and clear, warm turquoise waters.

A legend was born.

Best of all, each Residence features mesmerizing, panoramic views of the ocean.















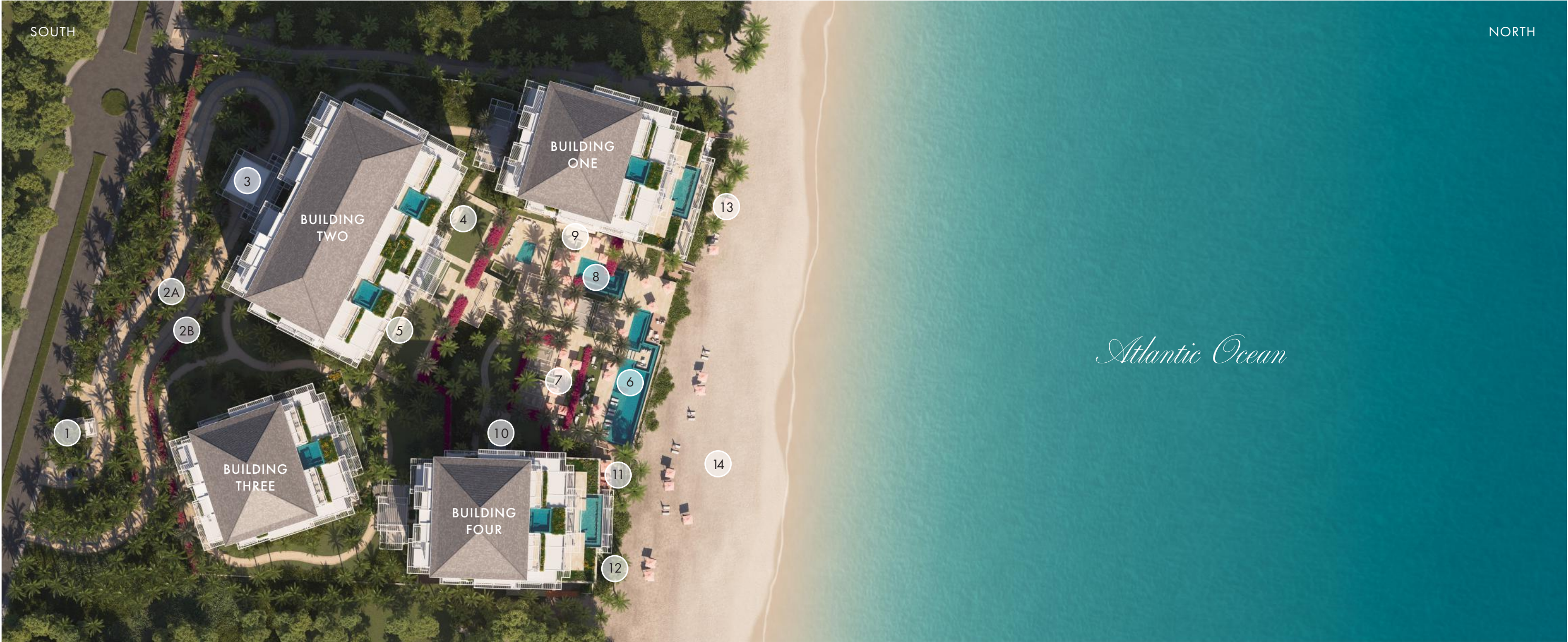
Twice the Fun

WHAT ARE THE OCEAN CLUB, FOUR SEASONS RESIDENCES, BAHAMAS?

The Ocean Club, Four Seasons Residences, Bahamas is a gated, curated collection of just 67 private, turnkey, Four Seasons-managed luxury full-ownership condominiums on Paradise Island, being developed with the owner of the iconic The Ocean Club, A Four Seasons Resort.

WHAT ARE THE RESIDENTIAL OFFERINGS?

- » Two-bedrooms plus a den averaging over 3,100 sf of interior living space with over 850 sf of exterior living areas
- » Three-bedrooms plus a den averaging over 4,000 sf of interior living space with over 1,200 sf of exterior living areas
- » Four-bedrooms plus a den with a 1-bedroom Residential Suite, averaging over 5,000 sf of interior living space with over 1,400 sf of exterior living areas
- » Penthouses with four bedrooms plus a den averaging over 5,200 sf of interior living space with over 3,900 sf of exterior living areas with private pools
- » Beach Villas with five bedrooms plus a den, with over 7,400 sf of interior living space and over 6,600 sf of exterior living areas with private pools

WHAT BENEFITS WILL RESIDENCE OWNERS ENJOY?

Owners and their families will own part of a legend—and enjoy the privacy, amenities and service for which the resort is celebrated.

When in residence, owners, their families and friends can enjoy ideal venues for celebrations, expansive indoor/outdoor entertaining spaces, a beachfront restaurant, bar and Owners Lounge, Spa and Fitness Center, Kid’s Club, pools and dining options – and, of course, The Ocean Club, A Four Seasons Resort. They will have access to the Tom Weiskopf-designed

championship golf course as well as the nearby Atlantis resort pools and recreational facilities for children.

When not in residence, owners can leave knowing that the Four Seasons staff will care for their homes, preparing their Residence for their return or (at the owner’s option) managing the rental of their Residence. Participation in the rental program can offer significant tax benefits through the Bahamas’ Hotel Encouragement Act.

WHAT ARE THE BENEFITS OF HOME OWNERSHIP WITH FOUR SEASONS?

Owners enjoy special recognition at all Four Seasons properties around the globe, with the same high standards of service they expect at home.

WHAT AMENITIES WILL THE RESIDENTS HAVE ACCESS TO?

The winding, manicured entry road past a security guard leads to a porte cochere and fountain. Inside, the Lobby Lounge will feature a concierge, bar, a light food/provisions store, Owners lounge and library, co-working center, conference and private dining room, Owners Private Cellar ...all overlooking verdant gardens with the Atlantic Ocean beyond.

Beachfront, the Restaurant and Bar will feature main and private dining rooms, an Oceanfront swimming pool, pool deck and cabanas, and a private Residents’ Club Lounge and spacious veranda.

The Kid’s Club will feature game and screening rooms close to the family pool.

Across the beachfront pool from the Beach Club, the Spa will feature a reception area, a Relaxation Lounge, indoor and outdoor treatment rooms, and lockers.

Adjacent to the Spa will be a state-of-the-art Fitness Center with strength training equipment, a Yoga Studio and outdoor deck.

Residents will also enjoy valet and underground self-parking, as well as golf cart parking and storage.

WHAT FEATURES DO THE RESIDENCES, THE BEACH VILLAS AND PENTHOUSES IN PARTICULAR, HAVE?

All Residences, feature oceanfront and/or ocean views, with extensive outdoor terraces for indoor/outdoor entertaining. All have open floorplans, are filled with light from extensive walls of glass, and feature premium fixtures, cabinetry, fittings and details.

There are two grand 5-bedroom/5-bathroom + 2-powder room Beach Villas, located directly on the oceanfront, featuring:

- » 7,459 sf of interior living area and 6,604 sf of outdoor living terrace, including a private plunge pool
- » 13-15-foot ceilings in major areas
- » Extensive outdoor, oceanfront decks and gardens with private pools
- » Large great rooms with wet bar, formal dining rooms, family rooms and dens/offices
- » Gourmet kitchens with butler’s pantries
- » Owners’ storage and beach storage

There are five 4-bedroom/5-bathroom + 2-powder room Penthouses among the 4 buildings, all featuring:

- » An average of 5,263 sf of interior living space and 3,917 sf of outdoor terraces, including a private plunge pool
- » 13-15-foot ceilings in major areas
- » Spacious Great Rooms / Dining rooms / Kitchens with indoor/outdoor bars and Butler’s Pantries
- » Family Rooms with access to dining terraces, plus a Den/Flex Room
- » Master Bedrooms opening onto beachfront terraces and pool areas
- » Sumptuous five-fixture bathrooms with private outdoor lounges

WHAT ARE THE BENEFITS OF OWNING PROPERTY IN THE BAHAMAS?

Air travel to the Bahamas is plentiful and convenient, with direct flights to Nassau’s Lynden Pindling International Airport (NAS) from 10 countries and 50 cities, including direct international flights from Toronto, Calgary, London and others.

NAS has direct flights from major gateway cities in the United States, including Miami, Orlando, Fort Lauderdale, Atlanta, Chicago, Charlotte, Dallas, Houston, Washington, D.C., Philadelphia, New York, Newark, and Boston. There is also a convenient seaplane option offering flights from Florida. For those who travel by private aviation, NAS offers a full range of FBO services from their VIP Terminal.

U.S.-bound passengers from Nassau’s Lynden Pindling International Airport conveniently clear Customs and Immigration on the ground in Nassau, as NAS is a U.S. pre-clearance facility. The airport also has the convenience of Automated Passport Control (APC) kiosks for faster processing through U.S. Customs.

A real estate purchase at The Ocean Club, Four Seasons Residences, Bahamas meets the criteria for Economic Permanent Residency in the Bahamas, which gives the individual the right to reside permanently in The Bahamas and travel freely to and from The Bahamas (but does not confer citizenship or the right to be employed in The Bahamas). FAQ

TO WHAT WEATHER STANDARDS WILL THE RESIDENCES BE CONSTRUCTED?

Ground floor elevations of 16 feet (Buildings 1 & 4) to 40 feet (Buildings 2 & 3) provide natural protection. Also, renowned Florida-based architects SB Architects have incorporated the best-in-class Miami-Dade “High-Velocity Hurricane Zone” standards into construction of each of the buildings.

WHAT IS THE CONSTRUCTION TIMELINE FOR THE RESIDENCES?

Groundbreaking is slated to take place in 2024. The Residences are expected to be ready for occupancy after approximately 36 months of construction.

WILL THERE BE HOA FEES? IF SO, WHAT WILL THEY COVER?

Yes. HOA fees will be payable by each owner based on their Residence’s proportional interest in the project and the amenities. The fees will include the cost of maintaining the project’s common areas, the residential building structures and common areas, and the operational and administrative cost incurred by the Association.

WHO ARE THE DEVELOPERS?

The Residences are being developed jointly by Access Industries – the owners of The Ocean Club, A Four Seasons Resort - and Two Roads Development of Florida, developers of Elysee in Miami and Forté in West Palm Beach.
