## Scrivener's Affidavit

- An Amendment and Restatement of Master Deed and Declaration of Condominium Documents for Bear Hill Estates Senior Condominium, which was recorded in the Hampshire County Registry of Deeds in Book 9378, Page 11.
- 2. An Amendment to Master Deed adding Phase XIII and other amendments dated December 31, 2016 and recorded in the Hampshire County Registry of Deeds in Book 12773, Page 145.

WHEREAS, there are drafting errors in the Amended and Restated Master Deed and Declaration of Condominium Documents for Bear Hill Estates Senior Condominium recorded as aforesaid in Book 9378, Page 11 as follows:

- 1. Article VIII should state after Article VIII "Intentionally Deleted" in the Declaration on Page 109 in Book 9378.
- 2. After the words "Intentionally Deleted" there should be inserted "Article IX Miscellaneous" on Page 109 of the Declaration in Book 9378.
- 3. In the By-Laws on Page 100 subparagraph (c) in Article II should read 7.08 and not 7.10.

WHEREAS, in the Amendment to Master Deed recorded as aforesaid in Book 12773, Page 145 there are a few typographical errors as follows:

- 1. On Page 152 of said Amendment subparagraph 2(a) the reference to Subparagraph 17.01(2) is incorrect and should read subparagraph 17.01(e) and should so read.
- 2. The reference to Page 10 on Page 152 of said Amendment Subparagraph 2 should reference Page 1 and should so read.
- 3. All of the references on Subparagraph (2) on Page 152 of said Amendment refer to the Amendment and Restated Master Deed and do not refer to the By-Laws of Bear Hill Estates Senior Condominium.
