RIVERCREST CONDOMINIUMS  
Adding Unit 1**

**RIVERCREST CONDOMINIUMS, LLC** Declarant of Rivercrest Condominiums, Master Deed of which is recorded with the Hampshire County Registry of Deeds in Book 12264, Page 51, pursuant to the rights reserved to said Declarant in said Master Deed, does hereby add one Building containing Unit 1 by amending said Master Deed as follows:

1. Section 2 of said Master Deed is hereby deleted and replaced with the following

**2. Description of Buildings**

Rivercrest Condominiums, dedicated by this Master Deed as amended, consists of sixteen (16) buildings which have no names, one containing Unit 1, one containing Units 2 and 3, one containing Units 4 and 5, one containing Units 6, one containing Units 7 and 8, one containing Units 9 and 10, one containing Units 11 and 12, one containing Units 13 and 14, one containing Units 15 and 16, one containing Units 17 and 18, one containing Units 19 and 20, one containing Units 21 and 22, one containing Units 23 and 24, one containing Units 25 and 26, one containing Unit 27 and one containing Units 28 and 29. In total, there are twenty nine (29) Units in the sixteen (16) Buildings.

The Buildings are primarily of wood-frame construction built on a concrete foundation, with a basement, vinyl siding and an asphalt shingle roof. The Buildings are located off Ferry Street, South Hadley, Hampshire County, Massachusetts.

A site plan showing the location of the Buildings dedicated to the Condominium is entitled *Condominium Site Plan of Unit 1 Prepared for Rivercrest Condominiums Ferry Street, South Hadley Massachusetts, Owned by Rivercrest Condominiums, LLC* dated August 28, 2018 prepared by R. Levesque Associates, Inc. has been recorded with Hampshire County Registry of Deeds in Book of Plans

The Condominium development as presently contemplated may consist of 18 Buildings, with a total of 31 residential units. The Declarant is under no obligation to build or dedicate any additional Buildings or Units to the Condominium and has reserved the right to add additional land, Buildings and Units in excess of the presently contemplated 18 Buildings containing 31 residential units per this Master Deed.
